1) Practical work

Mr Richard works as a postman for the Post Office. He is on very bad terms with his neighbours Mr and Mrs Jack. On a letter to be delivered by the Post Office to Mr and Mrs Jack, Mr Richard has written racially offensive and defamatory message on the back of the envelope.

Can you consider whether the Post office is vicariously liable in tort for the act of Mr Richard?

You should consider the question only from the point of view of vicarious liability. Case-law: Smith/stage, Lister, Mattis/Pollock.

- 2) Answer two of the following questions
- 1) Causation and the intervening act of the claimant: Discuss the problem of suicide of the claimant.
- 2) As far as private nuisance is concerned describe the factors taken into account for determining the reasonable user
- 3) As regard defamation, analyse the following condition: Does the statement refer to the claimant?

John, who has a licence enters the estate to go fishing.

John who is fishing peacefully from the river bank is approached by Peter and Zag. John who has a fear of dogs, starts to run away. Zag chases him as he is trained to do and John stumbles down the bank into the river, striking his head on a large rock. John intends to sue Peter for negligence

Consider whether there is breach of the duty of care by Peter.

Case-law: Blyth/Birmingham 1856, Bolton/Stone, Scott/St Katherine Docks 1863
